#### Complaint on the Provincial Consultations on the Traditional Courts Bill [B1 - 2012]

The Traditional Courts Bill (B1-2012) is draft legislation that was introduced to parliament in March 2008. The Department of Justice and Constitutional Development said that the Bill was to give more South Africans improved "access to justice" by giving proper recognition to the traditional justice system in a manner consistent with values in customary law and the Constitution. The Bill met with much resistance because many argue that it was inconsistent with both customary law and the Constitution.

On 13 December 2011 the department and the NCOP advertised the identical bill for public comment. The comments must be submitted to the department and the secretary of the NCOP Select Committee by 14 February 2012.

The Bafokeng Land Buyers' Association, is a voluntary association of rural traditional communities and individuals based in Rustenburg, many under the traditional authority of the 'Royal Bafokeng Nation'. Members of the Association, many of whom are poor and elderly, have terrible experiences with the Bafokeng Tribal Court and the conduct of the Bafokeng Chief in office.

There are currently a number of disputes lodged in the Mafikeng High Court and other statutory bodies against the Bafokeng chief. Our Association is a Party to the ongoing case 999/08 at the North West High Court in Mafikeng. The chief's territorial and traditional authority over communities that lodged land claims is in dispute. For various reasons, many of our members believe the chief is himself not fit nor competent to preside over the Tribal Court as the bill proposes.

The Association held a Conference at Berea on the 15-17 January 2012 together with a number of other organisations whose list is appended hereto. A number of concerns at the Conference emerged on the procedural and substantive flaws of the bill. We hereby wish to

bring those concerns to the attention of the North West Legislature and the committee responsible for the bill.

Procedural flaws on the bill: (not exhaustive)

A thorough awareness programme about the bill in our area has not been conducted;

2 In terms of the timetable for the bill, little time has been afforded for community consultations/participation:

The select committee that will consider the bill is made up entirely of men whilst the bill 3 will affect all people on communal land, the majority of whom are women;

Substantive flaws on the bill: (not exhaustive)

1. The parties attending customary courts are denied legal representation;

There is no separation of powers where the traditional leaders are lawmakers, 2. administrators and the judiciary;

3. Other traditional structures, kgotla and families are denied their customary traditional

roles to resolve disputes;

The bill allows the traditional leader excessive powers to sanction forced labour; deprivation of customary benefits (land rights and community membership); and a threat to security of tenure.

In light of the above, we, the individuals, communities and organisations listed below intend to make submissions on the Bill.

We request however that you take urgent steps to ensure that this process is one of meaningful consultation, which includes requesting for a postponement of the deadline to enable you to properly create awareness of the contents of the Bill.

In terms of your constitutional duties set out in section 72, you are obliged to create enabling conditions for public involvement and conduct your functions in an open and transparent way. The bill will affect the rights of many of our people in a manner adverse to their Constitutional rights. We need a thorough public involvement in the parliamentary process. This will further ensure that the public participation process is more than a mere formal exercise.

Given the bill's current form and its abovementioned inadequacies, we would require of the bill to be withdrawn. We request the Legislature to bring the bill closer to the people and communities affected by the bill, and to make means for those communities to fully engage with the bill and the process in a meaningful way.

We would further request that you keep us abreast of all developments with regards to this process. You are kindly requested to contact the undersigned for further arrangements.

RUSTENBURG LOCAL MUNICIPALITY'S VIOLATION OF A FUNDAMENTAL HUMAN RIGHT AND NOTICE OF AN URGENT MARCH DEMONSTRATION RE: TRADITIONAL COURTS BILL [B1-2012]

On the 23<sup>rd</sup> September 2010, the community of Luka, enraged by the illegal demolition of their private properties by the Bafokeng Tribal Police, <u>duly lodged</u>, in terms of the Gatherings Act of 1993, a notice to the Rustenburg Local Municipality for a protest march at Luka village. The envisaged protest march was intended to present a memorandum of demands from the Luka Community to Kgosi Leruo Molotlegi of the Bafokeng 'tribe'.

On the 29<sup>th</sup> September 2010, Mr Shoes Seshabela, the presiding officer of the triangle meeting and an official of the Rustenburg Municipality, refused to grant support to the community march on account that:

- (1) 'Permission' or 'authorisation' of the march had to be obtained from the very person the march was against,
- (2) The intended recipient of the 'memorandum of demands' needed to give expressed confirmation, by signing an acceptance/acknowledgement letter, that he will personally be present and available to receive the memorandum.

The wrong interpretation of Section 3(3)(j) of the Act by Mr Seshabela and other Municipal officials, led to a number of 'applications' by the Chaneng Community and Phokeng Youth to be similarly dismissed.

We wish to highlight to the Executive Mayor, that it is not a requirement of the Act, for the intended recipient of the memorandum of demands to 'authorise/permit' the march or to (personally) acknowledge receipt of the notice to march, as wrongly interpreted by the Municipal officials. It is unconstitutional to refuse assistance to the aggrieved, peaceful communities wishing to exercise their freedoms, in particular their fundamental right to demonstration.

Please be advised that the Act provides for a 'notice' to march, and <u>not</u> an 'application to march' as commonly misinterpreted by the Municipal officials. It would equally be an embarrassment for Municipal officials to disturb a picketing demonstration of less than 15 people, which does not require notification to authorities.

Our Association and other members of the public, intends to raise serious concerns about the Traditional Courts Bill currently out for public comments. The closing date for public submissions and presentations has been set for the 15<sup>th</sup> February 2012, only two months since the call in mid December 2011.
