


Molao Kakanywa wa Setso le Merafe ya maKhoi-San (TKLB) [B23-2015]

1. Maikakelo a molao o ke go fa merafe ya maKhoi-San tetla ya semolao ka gonne ba ne ba sa fiwa matla a go nna ka fa molaong le go leka go dira molao o le mongwe o o laolang dipuso.


Mme fela gona le matshwenyego ka molao o, a gore:

2. Ga o fetole melelwane (boundaries) e e beilweng ke Molao wa Puso ya Batho Bantsho ya 1951 (1951 Bantu Authorities Act) e ileng ya amogelwa ke Traditional Leadership and Governance Framework Act (2003)
 - i. Merafe (tribes) e fetogile ‘traditional communities,’
 - ii. ‘tribal authorities’ = ‘traditional councils’
 - iii. Melelwane ya ‘traditional councils’ e busetsa diBantustan. (Clause 70)
3. E pateletsa Batho go nna se eseng sona, e konotelela melelwane e le go pateletsa batho go wela mo bogosing bo ba sa bo amogeleng (ja ka mehla ea mmuso wa khethollo). (Clause 3&4)
4. E buseletsa bosemorafe le go kgaoganya batho go ya ka metse selegaeng le metse setoropng.
5. E leka go kgapela thoko go palelwa ga mmuso go fetola melao e e laolang bogosi kapa go rarabolola dingangisano tsa bogosi ja ka tsamaiso ya Nhlapho Commission le go tlhophiwa ga magosi.
6. E lettelela puso go fa magosi dithata dingwe le dingwe tse e batlang go ba fa tsone (Clause 15, 19, 20 & 25)
7. Ga e letle go morafe/motse go tsaa karolo pele ga go tswewa ditshwetso
8. E sireletsa bahumi (the rich) ba mo metseng le go ba humisa le go feta haholo bagosana le ba bangwe empa merafe esa humane sepe. E dumella dikhansele tsa bogosi go kenya mo ditumellanong le dikhamphani kapa masepala ntle le tsebo ea morafe.
9. Ga e latelele molaotheo mo go tlhaloganyeng melao ya setso e foto-fetogang le dinako. E berekisa kutlwisiso ea setso ja ka mmuso wa kgethollo.
10. Ga e tshware Magosi a setso (traditional leaders) le magosi a maKhoi-San ka go tshwana: Magosi a setso a tla busa mo mafatsheng a a riling, fa magosi a ma Khoi-San ba tlide go tlhoka mafatshe.
