

### ACADEMIC ACTIVITIES

Comparative Law and Business in Africa (CLBA) - LLM Course

The CCLA launched its new course. Comparative Law and Business in Africa (CLBA) as a first semester block course from 2nd - 20th March 2020. The course was coconvened by A/Prof Ada Ordor and Dr Nojeem Amodu, working with a team of experts from various regions of Africa. These included the Director of the Nelson Mandela School of Public Governance, Prof Faizel Ismail, Dr Theodore Maiyaki from the University of Abuja, Dr Jonathan Bashi Rudahindwa from Universite Protestante au Congo and Mr Douglas Gichuki from Strathmore University, Nairobi. The inaugural class comprised of eight students from five countries (South Africa, Botswana, Namibia, Zimbabwe and Zambia).

The course provided content on regional instruments for mobility and trade in four regional economic communities (RECs), namely: SADC, EAC, ECOWAS and the Arab Maghreb Union (AMU). Furthermore, the course also specifically focused on the domestic legal frameworks for doing business in South Africa, Kenya, the DRC and Nigeria. Discussion panels were constituted on the following specialised topics: movement of people and informal cross-border trade; China-Africa business frameworks and trade facilitation in Southern Africa, with panellists - Dr Victor Amadi, Ms Adetutu Oluwaseyi, Ms Tebogo Lefifi and Ms Tsotang Tsietsi, respectively.




# LAW REGIONAL INTEGRATION AND DEVELOPMENT IN AFRICA (LRIDA) - LLM COURSE

This course was convened by Dr Ordor in the first semester, with 34 students from ten countries. In addition to foundational lectures on theories of integration and regional economic communities, the course featured a negotiation simulation exercise and guest lectures on the African Continental Free Trade Area (AfCFTA) by Prof Faizel Ismail and on Integration and the Movement of Persons by Dr Victor Amadi.

## CHINESE LAW AND INVESTMENTS IN AFRICA (CLIA) - LLM COURSE

Ms Tebogo Lefifi piloted the remote teaching of CCLA's flagship course Chinese Law and Investments in Africa (CLIA) in the second semester, with 18 students, with a number of guest lecturers, including Professor Xiaohu Zhang of Xiangtan University, China and Ms Julia (Zhang) le Roux, a practising attorney in South Africa who specialises in Chinese dispute resolution.

# LAW AND REGIONAL INTEGRATION IN AFRICA (LRIA) - LLB FINAL YEAR ELECTIVE

This course was introduced as a final year research focus group in the second semester of 2020 and was taught through seminars by Dr Ordor, Dr George Mukundi and Dr Victor Amadi. The course introduced students to the legal instruments that shaped the post-independence trajectory of African co-operation from the Organisation of African Unity (OAU) to the African Union (AU). It also gave students an overview of the treaties establishing various regional economic communities on the continent, including SADC, EAC, ECOWAS and COMESA, demonstrating the progressive philosophical and ideological underpinnings of African integration. The pioneer class was made up of nine enthusiastic students.

With the HoD's approval, both fellows were selected from within South Africa, given the covid-related restrictions on international and domestic travel and logistics. The 2020 fellows were Dr Victor Amadi, CCLA post-doctoral researcher and Ms Tebogo Lefifi, convener of the Chinese Law and Investment course and UCT doctoral researcher. Dr Amadi's research was on the topic: An Appraisal of the Effect of the Covid-19 Pandemic on the Movement of People in Africa, while Ms Lefifi carried out: A Comparative analysis of the regulatory frameworks for China Special Economic Zones and African Special Economic Zones.




