# LLM in Comparative Business Law in Africa.

The advancement of economic integration on the African continent makes a course which covers the legal frameworks for intra-African trade imperative. The CCLA is responding to this development with a plan to introduce an LLM/ MPhil programme in Comparative Business Law in Africa in 2020. The core courses proposed for this programme are Comparative Law and Business in Africa and Law, Regional Integration and Development in Africa. Two electives may be picked from a basket of commercial law courses. These include the CCLA's signature course Chinese Law and Investments in Africa as well as a key new course on Resource Revenue Law.


