


2020...what a year it's been...

We hosted a very successful launch event to celebrate the publication of our postdoctoral research fellow's book, Multi-sided music platforms and the law: Copyright, law and policy in Africa (Routledge 2020). We also produced a <u>podcast</u> showcasing green innovations and IP across Africa to commemorate World IP Day 2020. Our team also presented at webinars, online workshops and conferences with several research outputs that we share with you here. The Chair, Professor Caroline Ncube was inaugurated, with others, as a Member of Academy of Science of South Africa (ASSAf) at a virtual Awards Ceremony in October 2020. 

Publications

Our research work listed as "forthcoming" in our 2019 Newsletter have now been published. Building upon the evidence drawn from their WIPO scoping study on access to copyright works by persons with disabilities, Professor Caroline Ncube's paper (with Dr. Desmond Oriahkhogba and Professor Blake Reid), "Beyond the Marrakesh VIP Treaty: typology of copyright access-enabling provisions for persons with disabilities" (Journal of World IP) identifies and discusses specific access-enabling technologies for persons with various disabilities and shows how, and the extent to which states' ratification of the Marrakesh Treaty to Facilitate Access to Published Works for Persons Who Are Blind, Visually Impaired, or Otherwise Print Disabled (Marrakesh Treaty) has enabled the making of accessible format of copyright works for persons with disabilities.

Conferences



Website News & Views

The overarching theme for 2020 has been navigating through and adjusting to life during a pandemic. Pre-lockdown and COVID-19 surge in South Africa, we experienced a glimpse of normalcy as the IP Chair had the great pleasure of hosting the launch of Dr Chijioke Okorie's new book 'Multi-sided Music Platforms and the Law' at UCT's law faculty. Shortly after, Dr Okorie participated in a conversation on Kaya FM, centred around the intellectual property implications of artists taking their performances onto digital platforms in the wake of social distancing and subsequent cancellation of events.



Professor Caroline Ncube partnered with the Nelson Mandela School of Public Governance in a virtual colloquium to share her thoughts on COVID-19 and the African Continental Free Trade Agreement (AFCFTA), more specifically, how the AFCFTA could stimulate an inclusive and developmental post-COVID-19 economic revival. Prof. Ncube was went on to partake in a series of webinars, most notably, the webinars for African Small and Medium Enterprises (SMEs) organized by the World Intellectual Property Organization (WIPO).

As part of their research contributions, the IP Chair's Research Assistants were tasked with collating articles and news on IP issues and thereafter writing them up in piece for publication on the IP Chair website. The first piece, written by Morite Makola, focused on the Patent system's role in innovation and access in South Africa where he explored challenges to policy reform and South Africa's commitment in terms of the Doha Declaration.

In the second piece, Sanelisiwe Mthalane undertook a review of copyright related writings in the age of COVID19. The piece compared 'fair use' vs 'fair dealing' approach to copyright limitations and exceptions and ultimately, which may be more conducive for online learning and a digitised society. Muofhe Tshifularo shared her thoughts on the increase in domain name registration and disputes in 2020, exploring the primary means of domain name dispute resolutions via alternative dispute resolution platforms, per Regulation 4 of the South African ADR Regulations.

Other online contributions

Our team continues to use blogging to more effectively communicate our research and to attract new audiences.

Our postdoctoral research fellow, Dr Chijioke Okorie is the IPKat's Africa Correspondent. The IPKat is a blog that covers copyright, patent, trademark, designs, info-tech, privacy and confidentiality issues from international and national perspectives. As Africa Correspondent for The IPKat, Dr Okorie contributes to a more internationally representative IPKat blog and comments on IP matters on the African continent.

Professor Ncube occasionally blogs on her personal website on issues pertaining to various IP matters. In addition, both she and Dr Chijioke Okorie are contributors to the Afro-IP blog. Professor Ncube, Dr. Okorie and Dr. Oriakhogba occasionally blog on the AfronomicsLaw blog – a blog that focuses on the International economic law Landscape as it relates to the Africa. The book symposium on Dr. Okorie's new book – Multisided music platforms and the law: Copyright, Law and Policy in Africa, was published on AfronomicsLaw blog in March 2020.

In addition, Professor Ncube's post on "The musings of a copyright scholar working in South Africa: is Copyright Law supportive of emergency remote teaching?" was part of AfronomicsLaw blog's COVID-19 Symposium on Intellectual Property, Technology and Agriculture. Professor Ncube's piece questioned whether copyright is supportive of emergency remote teaching in alignment with the right to education in the higher education context.

In January 2020, the Chair held a research workshop for new and existing research students supervised by Professor Ncube or co-supervised by Dr. Okorie. It was an opportunity to share ideas on how to make the best of the research journey as well as the nature of support available to researchers from the Chair.

From March 2020 (once lockdown restrictions were imposed by the South African national government), our monthly internal research meetings where the team shared research work and discussed planned and ongoing research publications, moved online. We have also used online platforms and conferencing tools to continue to provide research supervision and support to several masters and doctoral candidates.

Graduations



Several PhD and Masters students under the Chair's research supervision, completed their studies this year and two participated in the virtual graduation ceremony held on 14 December. Cedrine Ernstzen undertook research on crypto-assets and graduated with her LLM in Commercial Law and Dr Caroline Mwaura completed her doctoral research on IP in Kenya's Oil and Gas sector. Her thesis is available here.

Our 4 LLB research assistants (Morite Makola, Sanelisiwe Mthalane, Muofhe Tshifularo, Bianca Bresler and Angie Montandon) also completed their LLB Degrees in November and will graduate in 2021.
