As you'll see from our conference and publication lists, our team spoke and wrote about diverse issues throughout the year.



Intellectual Property Law and Access to Medicines

We participated in a Book Launch for Srividhya Ragavan and Amaka Vanni (eds) Intellectual Property Law and Access to Medicines TRIPS Agreement, Health, and Pharmaceuticals (2021) on 23 November. The event was hosted by the Centre for Business Law and Practice at the School of Law, University of Leeds, UK, and the Center for Law and Intellectual Property at Texas A&M University School of Law, USA, and co-sponsored by the Chinese University of Hong Kong's Centre for Comparative and Transnational Law. The launch consisted of three panels (full program) and Prof Ncube spoke on panel 2.


Research activity
