








The South African Intellectual Property Law Journal co-edited by the Chair, Professor Caroline Ncube, continues to publish incisive research and insights on intellectual property law and developments in South Africa and other countries on the African continent. The 2019 issue is currently in production and will be available to the public in January 2020. Read more about the journal here.

Publications

Intellectual property and trade in intellectual property goods are significant issues for the recently ratified African Continental Free Trade Area (AfCFTA). The AfCFTA will cover an African market of 1.2 billion people and GDP of over \$2.5 trillion, across all 55 member States of the African Union. In "A principled approach to intellectual property rights and innovation in the African Continental Free TradeAgreement"a chapter in an edited book by David Luke and Jamie Macleod entitled "Inclusive Trade in Africa", Professor Caroline Ncube (with Tobias Schonwetter, Jeremy de Beer and Chidi Oguamanam) considers the means of innovationin Africa before reviewing the context of approaches to intellectual property rights across Africa and suggesting a framework for solving intellectual property issues on the continent. In particular, they discuss the procedural principles and substantial principles that can be followed for an appropriate approach to intellectual property rights in the AfCFTA.



In "Multi-Sided Music Platforms and the Law: Copyright, Law and Policy in Africa", Postdoctoral Research Fellow, Dr Chijioke Okorie explores the legal and regulatory frameworks surrounding copyright protection, competition and privacy concerns arising from the way multi-sided platforms use copyright-protected content in digital advertising. The book, published by Routledge, suggests how stakeholders in South Africa and Nigeria, may ingenuously reform and apply various legal and regulatory frameworks to address the issues, which arise from the manner in which multi-sided platforms use copyright-protected content in digital advertising.



The Chair, in collaboration with other researchers, conducted a scoping study on access to copyright works by persons with disabilities for the World Intellectual Property Organisation (WIPO). The scoping study was presented at the 38th Session of WIPO's Standing Committee on Copyright and Related Rights (SCCR). The team also presented their work at a SCCR side-event on "Technology and accessibility for people with disabilities" (See our Conference Presentation section, below for more details).

Publications

The African context and how IP law and policy can be best calibrated to achieve national socio-economic goals in African states are a huge part of work under the Chair. In this regard, Postdoctoral Research Fellow, Dr Chijioke Okorie has made suggestions on how some of South Africa's approach to competition law can be applied in the enforcement of IP-related provisions of Nigeria's recent Federal Competition and Consumer Protection Act 2019. Her paper entitled "An analysis of the IP-related provisions of the Nigerian Federal Competition and Consumer Protection Act 2019 has been published in Journal of Intellectual Property Law and Practice. Furthermore, in "Copyright in contest-created' works: Ugandan Court of Appeal weighs private interests and public benefit vis-à-vis Uganda's national anthem" Dr Okorie argues for ways in which the Ugandan Court of Appeal may have better balanced private Interests and public interests in the Issue of the Ugandan national anthem.


Conferences

Website News & Views

Our team members regularly share news and views on our website. Here's a summary of some of what we've shared.



Desmond Oriakhogba considers the helpful guidance provided by the Beijing Internet Court on the question of copyright works authored by Artificial Intelligence (AI). In "Beijing Internet Court refuses copyright for AI created work" (10 September 2019), he argues that whether under the provisions of the Copyright Act 98 of 1978 or under South Africa's Copyright Amendment Bill 2018, currently awaiting presidential assent, South African courts will find some guidance from the judgment of the Beijing Internet Court in recognising or denying recognition for the "AI Creator" and/or AI created works.

Somila Dondashe offers her thoughts on Professor Okediji's presentation on why decolonisation of IP matters in her article "Why decolonisation of IP matters - with Prof R Okediji" (14 August 2019).

It has become increasingly imperative for developing countries to use intellectual property to benefit global development goals, particularly global health; climate change and food security. In "International Conference on Intellectual Property and Development: How to Benefit from the IP System" (1 June 2019), Sima Gosa writes on the WIPO Conference at which the Chair presented her work on how developing countries should think about IP in the context of trade and regional initiatives.

In "The Agreement on African Continental Free Trade Area (AfCFTA) - Protocol on IP" (14 May 2019), Chijioke Okorie shares her thoughts on the AfCFTA Protocol on IP currently being negotiated at the African Union.

In "The proposed fair use exception under South Africa's Copyright Amendment Bill" (24 March 2019), Chijioke Okorie provides a breakdown of the various ambits of the fair use exception provided for in South Africa's Copyright Amendment Bill.

Other online contributions

In the latest issue of Altum Sonator, our LLB Research Assistant, Adelaide Lendore, published a paper on "Smart Contracts", where she explained the concept of smart contracts and explored the question of whether South Africa could be able to fully integrate smart contracts into its legal system.
