Prof. Caroline Ncube, DSI-NRF SARChl Research Chair in IP, Innovation and Development, University of Cape Town

Professor Caroline Ncube is the DSI/NRF SARChI Research Chair in Intellectual Property, Innovation and Development in the Department of Commercial Law at the University of Cape Town (UCT). She holds a PhD in IP Law from the University of Cape Town; an LLM from the University of Cambridge; and an LLB from the University of Zimbabwe. Before joining UCT in 2005, Prof Ncube lectured at the

University of Limpopo (formerly University of the North) and the University of Zimbabwe. Prior to that, she practiced as an attorney at Coghlan, Welsh & Guest.



Mr. Sherif Saadallah, Executive Director, WIPO Academy

Mr. Sherif Saadallah, Executive Director, World Intellectual Property Organization (WIPO) Academy, is a national of Egypt and joined the International Bureau of WIPO in April 1991, as Special Assistant, Office of the Director General. In January 1993, he was transferred to the Development Cooperation and External Relations Bureau for Arab Countries. Promoted as Head of that Bureau in November 1995 and became Director of that Bureau in 1997. In December 2003, he was

appointed as Executive Director of the Office of Strategic Use of Intellectual Property for Development (OSUIPD) and supervised the work of five Divisions in WIPO, namely, the Intellectual Property and Economic Development Division, the Small and Medium-Sized Enterprises Division, the Intellectual Property and New Technologies Division, the Creative Industries Division, and the Division for Public Policy and Development. Mr. Saadallah was responsible for the process that led to the successful adoption of the WIPO Development Agenda in 2007. In 2008 Mr. Saadallah was appointed Executive Director of the Department of External Relations where he supervised the work of the Intergovernmental Organizations and Partnerships Section and the Non-Governmental Organizations and Industry Relations Section, as well as the WIPO Coordination Office in New York. In January 2015, Mr. Saadallah became the Executive Director of the WIPO Academy.



Mr. Antony Taubman, Director, Intellectual Property, Government Procurement & Competition Division (IPD), WTO

Antony Taubman has served since 2009 as Director of the WTO's Intellectual Property, Government Procurement and Competition Division, with responsibility for a wide range of WTO activities in these fields including coordination on the intersections between public health, trade policy and the intellectual property system, with a particular focus on the international response to the COVID-19

pandemic. From 2002 to 2009, he directed the Global Intellectual Property Issues Division of WIPO (including the Traditional Knowledge Division and Life Sciences Program), covering IP and genetic resources, traditional knowledge and folklore, the life sciences, and related global issues including public health and climate, the environment, climate change, human rights, food security, bioethics and indigenous issues. An earlier appointment at WIPO covered development cooperation in Asia and the Pacific, redesign of the program and budget, and policy development.



Dr. Outule Rapuleng, Head of ARIPO Academy, ARIPO

Dr. Outule Rapuleng joined ARIPO in June 2017 as the Head of the ARIPO Academy. He is responsible for intellectual property human resource development and capacity building. Prior to joining ARIPO, he was Senior Partner at Adsense Consulting (IP Consulting & Training) in Botswana. He served as Acting Assistant Director -Commercialization with the Office of Research and Development at the University and as an IT Analyst (Assistive Technology) in the

Faculty of Education at the University of Botswana, coupled with part-time teaching. He worked at the Coca-Cola Company in Philadelphia, Pennsylvania, USA as IT Helpdesk Analyst. Dr. Rapuleng holds a Ph.D. (Intellectual Property and Traditional Knowledge) from Northwest University in South Africa. He also holds a Masters in IP from Africa University in Zimbabwe, a BSc in Information Systems from Drexel University, Philadelphia, USA, and a Diploma in Science Education (Biology and Physics) from the University of Botswana. He is a recipient of Executive IP Management training from WIPO as well as Innovation Policy training from the World Bank. He has also served as a Committee Member of the Human Resource Development Council (HRDC) through an appointment by the Minister, in the Research, Innovation, Science & Technology (RIST) committee. The committee is responsible for bridging the skills mismatch in Botswana, matching the supply of graduates with national needs and priorities.

Session 1: Copyright Tensions



Prof. Tana Pistorius, University of Auckland, Auckland, New Zealand

Tana Pistorius is a Professor of Commercial Law at the Business School of the University of Auckland (UABS). Tana is also the Head of the Department of Commercial Law in the UABS). Tana is the Programme Director of the Information Governance Programme. Tana was a professor of intellectual property law from 2003-2019 and the incumbent of the South African Research Chair in Law, Society and Technology at the University of South Africa from 2016 to 2019.

She is a qualified attorney and a notary of the High Court of South Africa and a senior adjudicator of the SAIIPL alternate dispute resolution panel for the .za domain-name system. Tana has an active interest in policy formulation at national and international levels. Tana has been involved in several World Intellectual Property Organisation (WIPO) projects, including the development of a Model Intellectual Property Policy for Universities and Research Institutions (2018-2019) and the development of national IP curricula for universities in Africa (2015-2017). She has also served as a tutor for the WIPO courses since 2001 and is one of the tutors regularly appointed to teach the WIPO intellectual property management course (DL450). Tana served on the executive committee of the International Association for the Advancement of Teaching and Research in Intellectual Property (ATRIP) from 2009-2017. She was the President of ATRIP from 2013 to 2015 and she remains actively involved in ATRIP as a Past-President. Tana is a member of the editorial board of the WIPO-WTO Colloquium, and she is an external co-editor of the Journal for Juridical Science (University of the Free State).



Professor extraordinarius Coenraad Visser

Coenraad Visser is a professor extraordinarius in the College of Law at the University of South Africa. His research focus was increasingly on Intellectual Property Law issues in developing countries. As a result, he became a special adviser to The World Bank on Civic Engagement, Empowerment, and Respect for Diversity, and a consultant to bodies such as the African Union, the American Law Institute, the European Patent Office, the International Federation of Library Associations and Institutions, the World Intellectual Property Organisation, and the

World Trade Organisation. As a researcher, he has authored or co-authored 25 books and about 100 publications in peer-reviewed accredited journals. He has served on the editorial boards of international journals such as Computer Law International and the International Review of Intellectual Property and Competition Law. He was the editor of the Annual Survey of South African Law and the South African Mercantile Law Journal, and is currently the editor of the Journal of Contemporary Roman Dutch Law.



Dr. Caroline Joelle Nwabueze

Joelle Nwabueze is an Associate Professor of Law. She graduated from University of Bern in Switzerland where she obtained her Doctorate in the field of intellectual property. Her postgraduate studies include LLM in intellectual property at University of Turin in Italy, Masters in Human Rights from University of Nantes in France, DEA from University of Yaoundé II Soa, and PhD with First Class Honours from Douala University in Cameroon. Joelle is a graduate from Handong International Law School in Korea where she did her legal training in international law. Her areas of interest

nclude law and development, digital law, interfaces between data-driven technologies and intellectual property, copyright, and traditional knowledge. She has led several research projects on information communication technology, intellectual property, and traditional knowledge. She has served successively as intern at the Traditional Knowledge Division of the World Intellectual Property Organisation, and as intellectual property consultant at the International Information Networking Centre for Intangible Cultural Heritage in the Asia-Pacific (UNESCO-ICHCAP). She has been a postdoctoral research fellow at the College of Law, University of South Africa under the South African Research Chair in Law, Society, and Technology. Her journey as Law teacher started in 2004. Since then, she has been teaching in various capacities at the following universities: Catholic University of Central Africa (UCAC) in Cameroon, University of Yaoundé II Soa, Chungnam National University in Korea, University of South Africa (UNISA), Université de Poitiers in France, and Enugu State University in Nigeria. She currently leads the Business Law Department at the Faculty of Law of Enugu State University of Science and Technology in Nigeria where she serves as editor of ESUT Law Journal. Joelle is now undergoing her second mandate as Chair Digital Futures at LEAC- International Council of Museums.



Prof. Klaus D. Beiter

KLAUS D. BEITER, born in Namibia, holds B.Iur. and LLB. degrees from the University of South Africa, and a doctorate in international human rights law from the University of Munich, Germany, where he wrote his thesis on the right to education under Prof. Bruno Simma, formerly judge at the International Court of Justice. He completed a postdoc as a Marie Curie Fellow at the University of Lincoln in the United Kingdom, researching the protection of academic freedom as a human right. Prof. Beiter focuses on the right to education, the right to science,

academic/scientific freedom, intellectual property and human rights, the extraterritorial application of human rights, and law and development. He wrote the first English-language monograph on the right to education under international law (Martinus Nijhoff, 2006), which has become a standard work on the subject since. He was an Affiliated Research Fellow at the Max Planck Institute for Innovation and Competition in Munich from 2013 until 2022, and, before that, from 2006 until 2013, a Senior Research Fellow. He is an ad hoc consultant to UNESCO, a member of the Consortium for Human Rights Beyond Borders in Heidelberg, an adviser to the global Right to Education Initiative in London, and an ambassador to the Observatory Magna Charta Universitatum in Bologna. He is a Professor of Law at North-West University in Potchefstroom, South Africa, where he teaches Intellectual Property Law, Socio-Economic Rights, and International Social Justice.

Dr. Sanya Samtani, University of the Witswatersrand, South Africa

Sanya Samtani is an academic, holding the position of Senior Researcher at the Mandela Institute, a premier research centre at the School of Law, University of the Witwatersrand in Johannesburg, South Africa. She conducts academic research, teach and supervise students across the areas of intellectual property, human rights, and international law. She also consults for public interest organisations and the government on matters relating to one or more of the above areas.



Assoc. Prof. Desmond Oriakhogba

Desmond Oriakhogba is an Associate Professor in the Department of Private Law at the UWC. He obtained his PhD from the University of Cape Town (UCT), South Africa; and Master of Laws (LLM) and Bachelor of Laws (LLB) degrees from the University of Benin, Nigeria. He is a Queen Elizabeth Scholar (awarded by the Canadian government). He is also an expert collaborator with international research networks, including the Open African Innovation Research Network, the International Network on the

Right to Research in International Copyright. Desmond is an independent consultant for the World Intellectual Property Organization (WIPO) where he tutors participants under WIPO Academy's distance learning programs. He is an associate editor of the South African Intellectual Property Law Journal, and was a visiting researcher in the Centre for Technology, Law and Society, Faculty of Law, University of Ottawa, Canada.



Dr. Andrew Rens

Dr. Andrew Rens is an accomplished Attorney, academic and policy advocate with an excellent history in public interest focusing on information communication technology (ICT) and intellectual property (IP) issues. At RIA, Dr. Rens researches AI policy, data governance and regulation of the digital economy. He recently completed research on AI and cyber risk, and data policy capacity building. He holds a BA and an LLB from Wits University, where he went on to graduate with a Master of Law, writing the

first research on Internet legal issues in South Africa. He earned a doctoral degree from Duke University for research on use of Creative Commons licenses for educational materials. Early in his career he served as public interest lawyer at the Wits Law Clinic, which serves some of the most disadvantaged members of South African society. While at Wits, Andrew also pioneered courses in Information Technology Law. Dr. Rens has been a Fellow at the Center for Internet and Society at Stanford Law School. From 2007 – 2010, Andrew was the first Fellow at the Shuttleworth Foundation where he worked on access to knowledge, IP law reform and open education in South Africa. Dr Rens has also been a fellow at the American University's Internet Governance Lab in Washington D.C. where he concentrated on regulation of artificial intelligence (AI) and the Internet of things (IoT).

Prof. Irene Calboli, Texas A&M University, United States of America

Irene Calboli is Regents Professor of Law at Texas A&M University and Academic Fellow at the University of Geneva. She holds several honorary and visiting appointments, including at SciencesPo Paris, the University of Melbourne, Singapore University of Social Sciences, National Law School Delhi, Bocconi University, and Stanford University. In 2022, she was a Fulbright-Hanken Distinguished Chair in Business and Economics in Finland and, in 2018, a Fulbright Specialist Scholar at the Royal University of Law and Economics in Cambodia.

She is a member of the editorial board of several scientific journals, including the Oxford Journal of Intellectual Property Law and Practice, the Queen Mary Journal of Intellectual Property, and the WIPO-WTO Colloquium Papers. An elected member of the American Law Institute and the European Law Institute, she serves on the board of several professional associations, including the Comparative Law and European Law Sections of the Association of American Law Schools, the American Branch of the International Law Association, the European Policy for Intellectual Property Law Association, and the International Trademark Association. She regularly advises national governments and international organizations, and is currently an Expert for the World Intellectual Property Organization, the World Trade Organization, the U.N. International Trade Center, and the European Union. Irene is a graduate of the University of Bologna, Queen Mary University, and the London School of Economics.



Ismail Nuruhussien Attayib

Ismail Nuruhussien ATTAYIB is a senior lecturer in Intellectual Property Law and coordinator of the LLM program in International Trade and Investment Law at Jigjiga University School of Law. He holds LLB and LLM in Commercial & Investment Law from Jimma University (Ethiopia) and a Master's Degree in Intellectual Property (MIP) from Africa University (Zimbabwe). Currently, he is working on his PhD at the University of South Africa.

Prof. Lonias Ndlovu, University of Venda, South Africa

Lonias is a professor and Director of the School of Law at the University of Venda (SA), where he has worked since August 2016. He served as the dean of the School of Law at the same university from 2019 to 2021. He holds a Bachelor and Master of Laws from the University of Fort Hare (SA), a Doctor of Laws from the University of South Africa, and a Postgraduate Diploma in Higher Education from the University of Kwazulu-Natal. Before joining the University of Venda, he worked at the universities of Fort Hare, Zululand, and North

He holds the Research Chair in Sustainable Bio-Innovation, Indigenous Knowledge Systems and Global Knowledge Governance. He is also a Co-founder of the <u>Open African Innovation Research (Open AIR</u>) Network and the founding Director of <u>Access and Benefit Sharing (ABS) Canada</u>.

Dr. Chidi Oguamanam is called to the Bar in Nigeria and Canada and is a member of the Nigerian Bar Association and the Nova Scotia Barristers' Society. He is also inducted to the Royal Society of Canada College of New Scholars, Artists and Scientists and holds several interdisciplinary research fellowships. Tebogo Lefifi is the Senior Program Manager: Stakeholder Relations at the Nelson Mandela School of Public Governance, University of Cape Town. She holds a PhD in Commerce: Chinese Law and Investments in Africa (University of Cape Town, 2023), an LLM in Chinese Business Law (Hong Kong Open University), and a BCom from the University of KwaZulu-Natal (1997). Since 2018, Tebogo has been convening and

teaching an LLM course and an executive development course in Chinese Law and Investments at UCT. Her expertise includes international business strategy and research, China-Africa relations, strategic marketing, and reputation management. In her previous roles, Tebogo has served as a senior government official and established the first official nation brand agency in China. In this capacity, she profiled and positioned South Africa and Africa to attract Chinese investments and promote market entry for African products in China. Tebogo serves on advisory boards for various China-Africa businesses and initiatives, including the Africa China Law Desk (ACLD). She co-founded the Sino-Africa Centre of Excellence (SACE), an applied think tank that published and conducted the China Business Perception Index in various African countries. She has also served on advisory boards for initiatives such as the China-Africa Wildlife Conservation Council (CAWCC), an Aspen Institute and Africa Wildlife Foundation initiative, Yale University's Visiting Women's Executive Exchange Program (VWEEP), and the South Africa China Business Association (SACBA). As a Junior Research Fellow at the UCT Intellectual Property Chair, Tebogo's research interests focus on the development of Chinese intellectual property as part of economic development strategy and lessons for the African Continental Free Trade Area (AfCFTA). She was a 2020 fellow for the prestigious Olu Akinkugbe Business Law in Africa Fellowships (OABLAF).
