#### **Security and Justice Futures** - a seminar series


The Faculty's Global Risk Governance Programme, based in Public Law, is cohosting a series of seminars with the Scottish Centre for Crime and Justice Research; the National Crime Research Centre; and the Institute for Development Studies, University of Nairobi. These bi-monthly webinars entitled Security and Justice Futures aim to confront the dilemmas, re-imaginings and futures of security and justice from a cross-regional perspective. Drawing from a range of speakers from north and south contexts, the series seeks to engage with both academic and practitioner audiences to encourage a mutual dialogue on the futures of security and justice in diverse contexts.

Seminar 1 | Who should the police be in the 21<sup>st</sup> Century? Date: Thursday, 29 February Time: 12:30pm-1:30pm (GMT) Venue: online (see link below)

The focus of this first webinar, chaired by Dr Julie Berg, will include talks from Dr Mutuma Ruteere (Director of the National Crime Research Centre, Kenya's state agency on crime research) and Professor Jennifer Wood (Professor of Criminal Justice and Vice Provost for Faculty Affairs at Temple University in Philadelphia, USA).

Dr Ruteere's talk entitled Where Does Policing Go From Here? Dilemmas of Policing in Africa will reflect on three critical dilemmas facing African policing - the search for new ideas; the impacts of governance changes; and, the implications of the technological revolution. Professor Wood's talk entitled *The Shifting Harmscapes* of Policing: Reflections on the Police Idea will examine the policing function in relation to shifting landscapes of harm, and reflect on the idea and mandate of the police in response to these shifts - particularly reflecting on the growing interconnectedness of health and climate harms.

#### Environmental, Social and Corporate Governance (ESG) Its History, Current Global Trend and Future





On 14 February 2024 the Department of Commercial Law hosted a seminar titled Environmental, Social and Corporate Governance (ESG) - Its History, Current Global Trend and Future, presented by Prof Jung, Hongjoo. The seminar was attended by staff and postgraduate students. JUNG, Hongjoo has been teaching at SungKyunKwan University (SKKU), South Korea since 1991, after obtaining his PhD in the area of Risk Management and Insurance at the Wharton School, University of Pennsylvania. Prior to that, he earned his BA in Economics at Seoul National University, and his MS in Statistics at New York University.

Prof Jung, Hongjoo has written over 15 books and 40 papers in distinguished academic journals with research interests focusing on the financial consumer, risk management, and social security systems. Professor JUNG has served as a member of advisory groups at several governmental ministries of Korea in economy, finance, labour, education, information & telecommunication, and agriculture. In the year 2010, Prof JUNG organised the Korean Academy of Financial Consumers (KAFC), a legal entity registered at the Ministry of Strategy and Finance, with over 180 scholars and experts in finance, law, consumer science, or education, in order to analyse, educate, protect the financial consumers from an independent and professional perspective.

As of 2019, he serves as the chairperson of the International Academy of Financial Consumers (IAFICO), a platform of global research on Financial Consumers. He was also involved in research institutes in Waseda University Japan and in Fudan University China, while participating in editorial board of Journal of Consumer Affairs in the USA.
