




Friday 8 March is International Women's Day, being celebrated this year under the theme 'Invest in women: Accelerate progress'







The judiciary faces a barrage of attacks not just from the ruling ANC but from other political parties clamouring for power. There comes a predictable phase in the cycle of politics where this is most likely to occur. Why does it benefit political parties to deflect from their failure to deliver with calls for parliamentary sovereignty? Why do so many myths circulate about the nature of our courts and constitution? *Capture in the Court* provides much-needed insight on these pressing issues. The book, published by Tafelberg, was on the Exclusive Books Bestseller List for 2023.

#### About the speakers

Dan Mafora is a lawyer and a commentator on South African law with a focus on constitutional law. He works in advocacy and public interest litigation. He previously worked for the Constitutional Court of South Africa. He writes about law, philosophy, politics, writing, literature, and the relationships between them. He is a masters student at the University of Cape Town, working on his thesis in constitutional law and theory.

**Professor Anthony Diala** is a professor of law and foundation director of the *Centre* for Legal Integration in Africa at the University of the Western Cape. He is also coeditor-in-chief of the African Journal of Legal Studies.



The book - titled L'Art de bien parler - is available in French and is published by Livre de Poche (the French equivalent to Penguin Books). The publisher's summary shares the following (roughly translated) paragraph

#### **Feminist Encounters: A Journal of Critical Studies** in Culture and Politics

Prof Pierre de Vos and Prof Jaco Barnard-Naude have both just published articles in Feminist Encounters: A Journal of Critical Studies in Culture and Politics.

**Prof de Vos's** article is titled entitled "We Hope He Will Be Dead by Tonight': Shared Estrangement in the ICU of the Universitas Hospital, and recounts (according to the journal's online abstract) the week in which the author and his four sisters spent waiting for their father to die, and suggests that intimacy or friendship viewed as 'shared estrangement' – a friendship or intimacy not rooted in sharing common ground - might provide a lens through which to consider the nature of the deep bond that developed between the author and his siblings during that week. Raising the possibility that the relationship between author and his sisters could in some ways be read as a queer one, not least because it demanded an openness to alterity and requires attention and care, mutual trust, and, bizarre as it may sound, even betrayal, the author suggests that a deep bond slowly developed between the siblings during the week being described, not despite the profound differences between the siblings, but partly because of it.

**Prof Barnard-Naude's** article is titled And Losing Thus the Boundary / Of the Finite Me, Diffusing Outward, I Approach / The Edges of Infinity' (Plath, 2020: 133) – The Two Dimensions of Extimacy in Contemporary Psychoanalytic Thought. According to the journal's online abstract, the article investigates the meaning and value of Jacques Lacan's term 'extimacy'. It argues that there are two competing notions of extimacy at work in the literature, a negative one (which dominates the literature) and a positive (nascent) one, which is not yet fully worked out in the literature and to which this contribution offers a form of development through the recourse to the instance of the (love) letter in the unconscious. The author associates the positive 'valence' of extimacy with what Paul Cilliers calls 'a certain slowness' which is inextricably tied up with reflection as one of the fundamental features of any successful psychoanalysis, namely an analysis that passes through the Act. The author shows how the writing of a love letter – as an instance of slow reflection – not only exposes a (repressed) positive dimension to extimacy, but also (and perhaps because of this) qualifies as an instance of more or less successful self-analysis – what the author associates with a psychic progression of sorts.

#### **ENGAGED SCHOLARSHIP**

On 22 February 2024, the UCT Tax Institute and the IBFD organised a joint public lecture series discussing the OECD Tax Initiative on Pillar II (the introduction of a minimum global corporate income tax). Ben Cronin and colleagues from the Commerce Faculty participated in a lively discussion at the Century City Conference Centre. The public lecture series was extremely timely as the Minister of Finance introduced to Parliament the Draft Global Minimum Tax Bill the day before, on 21 February.
