

### **Staff Welcomes**



A Reader in Criminal Law at The Dickson Poon School of Law and the author of Courts in *Conflict: Interpreting the Layers of Justice* in Post-Genocide Rwanda (paperback OUP, 2019), Nicola has written on questions of resistance to mass violence, methodological approaches to transitional

justice and the intersections of plural legal processes set up in response to exceptional violence. Nicola received her DPhil in law from Oxford in 2011 where she studied as a Rhodes Scholar. Prior to this, she worked at the United Nations International Criminal Tribunal for Rwanda (UN ICTR), following her undergraduate in law and economics at Rhodes University in Makhanda, South Africa.

### **Visiting Fellow**



The Faculty is delighted to be hosting **Dr** Rajnaara Akhtaar on a one-week Fellowship. Based at University of Warwick in the UK, Dr Akhtar is a sociolegal researcher with a focus on family law. In particular, her research centres on marriage formalities and legal treatment of non-legally binding religious-only marriages. Her research into such marriages looks at transitional relationship norms, normative influences, legal consequences and autonomy.

She has conducted extensive empirical research on family law and family justice processes in the UK, Qatar and Australia. Her work draws on a range of socio-legal theories and approaches, and is underpinned by Critical Legal Theory. Dr Akhtar has collaborated with Prof Waheeda Amien on an international multidisciplinary research project proposal to the UK-based Economic and Social Research Council focusing on Muslim marriage contracts, for which they're awaiting the outcome. The week-long visiting fellowship at UCT is intended to begin work on the ground to build research networks within communities and with legal professionals dealing with family law issues. Dr Akhtar hopes that this visit will help to build research networks and to continue her research on Muslim family law issues, taking a comparative approach.


Dr Akhtar presented a staff seminar on Tuesday 6 August on the topic "*Non-legally* binding marriages and the state – England, Qatar and Australia".

#### **Call for Contributions - Alchemical tales** A conference in honour of Albie Sachs





### **PUBLICATIONS**

The Law of Succession in South Africa



The Law of Succession in South Africa is the leading book on the subject. It was first published in 1980 by the former Chief Justice of South Africa, MM Corbett and his coauthors Ellison Kahn, HR Hahlo and Gys Hofmeyr and subsequently revised by the authors in 2001 (second edition).

22 years later, the third edition (2023) builds on the work of the original authors, who not only systematised the study of the law of succession but commented extensively on every aspect of the law. True to its original form, the new edition by Adv Gys Hofmeyr SC and Prof Mohamed Paleker (with retired Judge of Appeal Ian Farlam who revised the technical chapter on Conflict of Laws) builds on the original text and comments extensively on developments that have occurred in the intervening period.

Adv Hofmeyr SC and Prof Paleker also considered many of the pre-existing principles of the law and looked at them through the lens of transformative constitutionalism. Mohamed says this was necessary because 'we have just assumed that the old law applies without interrogating whether they are constitutionally sound. A classic example is the so-called "Jewish race and faith clause" or the condition against remarriage. Both are acceptable in Roman-Dutch law and considered to conform to public policy, but the question is: are these black-letter rules/principles acceptable today? Due to legislative reforms and judicial interventions, many aspects had to be revised entirely. A case in point is the law relating to intestate succession.'

About his experience, Mohamed writes: 'It was a great honour to work with Adv Gys Hofmeyr SC on this project. Gys completed this book at the age of 91 with astounding academic rigour. Although we took responsibility for our chapters, we interrogated each chapter together and debated everything. Working with Gys was an incredible experience; I consider him my mentor and friend. We endured many challenges, including Covid and computer problems, and somehow prevailed."

Although published in 2023, this great publication was recently reviewed in the SALJ.

# **Comparative Civil Procedure and Justice Project**

**Prof Mohamed Paleker** is pleased to share that after four-and-a-half years, the Comparative Civil Procedure and Justice Project at the Max Planck Institute in Luxembourg has been completed. The purpose of the project was to document and analyse civil procedure laws from around the world to understand the law and to identify commonalities and differences. The project team, consisting of six people including Prof Paleker, was assigned to segment 6, which focused on the rules of jurisdiction. More broadly, in addition to studying common areas of civil procedure, the project also explored newer areas, such as online dispute resolution and the use of artificial intelligence in civil justice. The research was quite challenging, as civil procedure is intricately linked with substantive law and the legal system of a country. This interconnection often makes understanding procedural law a complex task.

The culmination of this research will be published online as open access, providing a valuable resource for scholars to further their understanding of civil procedure. "Personally," said Prof Paleker, "this project has been a rewarding experience, allowing me to travel, engage with proceduralists and immerse myself in diverse legal systems. I wish to thank our law librarians for the assistance they afforded me to source books and materials."

#### Bringing legislative learning to life

In an exciting development at the University of Cape Town (UCT), **A/Prof Cathleen Powell** has spearheaded the creation of a gaming app designed to transform the way law students engage with the legislative process. The app, "Pass a Bill", is currently available to Constitutional Law undergraduate students and, according to A/Prof Powell, has already been in use for some time.

This innovative tool introduces a dynamic and interactive learning environment, which aims to deepen students' understanding of complex legal procedures through immersive gameplay. The app challenges players to navigate a bill through the intricate pathways of legislative approval, making critical decisions at key junctures based on provided information. By simulating the real-life processes that bills undergo in South African Parliament – ranging through proposals from the National Assembly, scrutiny by the National Council of Provinces, and mediation where these bodies disagree – the game offers a hands-on learning experience that is both educational and engaging.
