## NARRATIVE ON MY CV

Throughout my career, I have sought to make legal education more thoughtful, inclusive, and relevant to the lives of ordinary people. Law should not only teach rules but also encourage students to ask who the law serves, who it excludes, and how it can be improved. As a teacher, researcher, law reformer, and university leader, I have worked to ensure that legal education remains grounded in justice.

I have taught law at UCT for over twenty years, instructing thousands of students and supervising more than twenty graduate dissertations, many of which have contributed meaningfully to legal scholarship. Several of my students have gone on to doctoral and postdoctoral fellowships at institutions such as Harvard and Oxford, while others have become influential lawyers and social justice advocates. I have received teaching awards at both university and national level, but what matters most to me is helping students, especially those from disadvantaged backgrounds, find their voice. I have taught students from Soweto to Llandudno, and I now teach the children of my former students. Regardless of language, class, or schooling, I want all students to feel they belong in our classrooms and within the legal profession.

My postgraduate supervision has supported bold, original research often rooted in empirical work and driven by the desire to bring about social change. Topics have included domestic violence mediation in Ghana, succession law reform, wealth redistribution, children's rights, juries in a post-apartheid context, online dispute resolution, and judgment writing. These projects have helped build the next generation of African legal scholars, many of whom now work in academia, policy, and public interest law.

My own research focuses on civil procedure, family law, succession, and access to justice, areas often overlooked but central to people's experiences of the legal system. I have published extensively on mediation, court procedure, inheritance, and legal transformation. Until 2024, I was a Max Planck Scholar, contributing to a global comparative law project on civil procedure. Our work, published in a multi-volume international encyclopaedia, addresses procedural fairness and access to justice across legal traditions. I also authored *The South African Sheriffs' Guide*, a practical tool that has improved accountability within an often-neglected part of the justice system.

Much of my scholarship is critical in nature. I have written on the limits of formal equality, the risks of unexamined judicial discretion, and how legal rules can reinforce structural inequality. In a recent piece, I examined how freedom of testation conflicts with constitutional values, showing how entrenched property interests and psychological biases hinder reform. Having contributed to the constitutional drafting process in the 1990s, I believe legal scholarship must not only interpret the law but also challenge it.

This critical lens also informs my law reform work. I have served on the Rules Board for Courts of Law in various capacities, including as chair of its Alternative Dispute Resolution and Small Claims Committees. I helped draft court rules, consulted on succession law reform, and trained over 100 mediators nationally. I have worked closely with the South African Law Reform Commission on projects related to family law mediation, relocation of children, and the review of outdated legislation. I have also collaborated with civil society organisations, including the Women's Legal Centre and the Gender Commission, offering strategic legal input on succession and family law matters.

Currently, I co-chair the National Small Claims Courts Committee with the Deputy Minister of Justice. I have long advocated for mediation and alternative dispute resolution and played a leading role in introducing court-annexed mediation in South Africa through Uniform Rule 41A and Chapter 2 of the Magistrates' Courts Rules. I have also contributed to reforms relating to access to information, administrative justice, and judicial sales in execution, particularly concerning vulnerable homeowners. My aim in all of this is to make legal processes fairer, more responsive, and accessible to all.

Internationally, I have presented at conferences on legal reform, civil procedure, and access to justice. These engagements have enabled me to bring African perspectives into global conversations and to draw comparative insights to inform our own legal developments. My work with the Max Planck Institute deepened my appreciation for the diversity of legal systems and their potential to learn from one another.

Within the university, I have served as Head of Department, chaired several faculty and university committees, including the Library Committee, the Legal Aid Clinic Steering Committee, and the Academic Planning Committee. I am currently involved in efforts to restore the Jagger Library. I have coordinated the LLB programme at various levels and chaired the Cape Town School for Legal Practice. My contributions to curriculum development, both formal and informal, aim to enhance student experience, modernise content, and promote inclusive, evidence-based transformation in legal education.

In these roles, I have learned to lead, collaborate, and manage scarce resources. Whether coordinating library restoration, overseeing training programmes, or working with the Department of Justice, I have developed budgets, set priorities, and navigated complex decision-making while keeping people and purpose at the centre.

Administration must support, not stifle, the academic mission. I have been openly critical of management practices that ignore staff needs or discourage innovation. Leadership, for me, means listening, acting with empathy, and making thoughtful decisions. I do not believe in micromanagement, but I do believe in responsibility and honest, principled governance.

While most of my external funding efforts have supported my own research and teaching, I understand the importance of financial sustainability. I maintain strong relationships with alumni, the profession, and public institutions.

I care deeply about my work. I bring energy, commitment, and focus to everything I do. I believe in teamwork, but I also step forward when leadership is needed. Above all, I want our work to matter and to leave behind something better than what we found.
