

PROGRAMME


The UCT Department of Commercial Law warmly invites you to attend the virtual launch of our new Corporate Law and Governance Unit (CLGU).

Professor Jacqui Yeats UCT Department of Commercial Director, CLGU

Professor Jacqueline Yeats BA LLB LLM (University of Stellenbosch) PhD (UCT), Attorney of the High Court of South Africa, joined the Commercial Law Department of UCT in 2005. She teaches company law and corporate governance at Postgraduate (LLB and LLM) level. Prior to joining UCT she practised as a commercial attorney at Werksmans and ENS. Her areas of interest, research and publication include company law, corporate governance, securities, fundamental transactions and shareholder activism. She is a co-author and the Managing Editor of Juta's multi-volume work, *Commentary on the Companies Act of 2008*. Jacqueline is the Director of the Corporate Law and Governance Unit.

Dr Helena Stoop

UCT Department of Commercial Law Senior Lecturer

Helena is a currently a senior lecturer in the Department of Commercial Law at the University of Cape Town. She was awarded the Commonwealth Scholarship in 2016 and commenced her PhD studies at Durham University in October of the same year. She was awarded her PhD in 2020 which focussed on the interaction between voluntary corporate governance codes of best practice and mandatory company laws, with an emphasis on the duties of independent non-executive directors. Her primary fields of interest are Company Law, Corporate Insolvency, Corporate Governance, Insurance Law, and Legal Education. She has published on various aspects of these topics in notable South African journals and journals abroad.
