

## 1. Abemi basemaphandleni basenokujamelana nokoxuthwa amalungelo abo omhlaba

Icandelo 24 lithi Amabhunga Emveli asenokungenela izivumelwao, ngaphandle kokucela imvume ebantwini omhlaba wabo okanye amanye amalungelo anokuchaphazeleka (jonga iphepha 30).


- ◊ Abantu abanamalungelo omhlaba wesintu kunye namalungelo omhlaba angamiselwanga ngokusesikweni abakhuselekanga, akuboniswana nabo okanye babuyekezwe, nto leyo ejongela phantsi iimfuno ze-Interim Protection of Informal Land Rights Act of 1996 (i-IPILRA).
- ◊ I-IPILRA ithi xa amalungelo abantu omhlaba oxuthwe ngokusemthethweni, kufuneka babuyekezwe.



## **2. Abemi basemaphandleni abakwazi kuwaphendulisa amagunya emveli ngokuba bayisebenzisa njani imali yoluntu**

I-TKLA ayinikeli ngazixhobo ezisebenzayo kubemi basemaphandleni ukuze bafumane ulwazi lokuba amabhunga emveli ayisebenzisa njani imali yabo.

- ◊ Yonke imali yoluntu lwemveli nokuba ivela kowuphi umthombo iza kuya kwiiakhawuntu zebhenki yolawulo lukarhulumente ((Jonga iCandelo 23 lomthetho kwiphepha 26).). Le nkqubo ibisetyenziswa eMntla-Ntshona kangangeminyaka ekhokele kulahleko olukhulu lwengxowa-mali yoluntu.
- » Uninzi loluntu lwemveli lumphulukene nesixa esikhulu semali ngenxa yezenzo zamabhunga emveli, iinkokheli zemveli noorhulumente bamaphondo.
- » Emntla Ntshona iBakgatla ba kgafela iphulukene phantse ne-R5 billion (jonga ingxelo yekhomishini kaBaloyi ku-<http://www.saflii.org/images/baloyi.pdf>), ngoxa iBapo ba Mogale iphulukene ne-R800 million (jonga ingxelo Yomkhuseli Woluntu ku-<https://www.customcontested.co.za/wp-content/uploads/2017/07/Bapo-Ba-Mogale-D-Account-Investigation-Report-002.pdf>).
- ◊ Nangona indlela yokugcina imali “nge-D-account” ibonakale iyintlekele kumabhunga esintu akwiphondo laseMntla Ntshona kodwa ngoku iza kusetyenziswa ngawo onke amaphondo.



### **3. Igcina iziseko zobukoloniyalı/zocalucalulo kwaye iphinde ixhase ijografi yeBantustan**

Ezi ndawo zasekwa ngokususwa ngenkani kwabantu ibe abanye abantu banyanelwa bakhethe isizwe okanye bafakwe phantsi kolawulwo Iwesizwe abangafuni ukuba siso.

- ◊ Izizwe zithiywa ngokutsha zibe yimimandla yesintu.
- ◊ Amagunya ezizwe athiywa ngokutsha ngamabhunga emveli.
- ◊ Imida yamabhunga emveli yakhe ngokutsha iBantustan yangaphambili (jonga iimaphu ezingasentla).
- ◊ Abantu abahlala ezilalini baza kuqhubeka bevaleleke kwezi ndawo zeBantustan eziqhubekekayo phantsi kwe-TKLA kune nokulawula ngegqudu kwamagunya esintu nawayeyilwe ngoorhulumente bamakoloniyalı nowocalucalulo.
- ◊ Ubukhulu becala eMzantsi Afrika, i-TKLA iza kusebenza kuphela kwezi ndawo.

#### **4. Ichasene nentando yeninzi nokuxhasa iingcinga zobukoloniyalı zomthetho wesintu**

I-TKLA iyaphambuka kwindlela inkundla zoMgaqo-siseko ewuqonda ngayo umthetho wesintu 'njengomthetho ophilayo' otshintshayo uze ukhule ngokuhamba kwexesha kwaye uchazwa ngabantu abaphila ngawo.

- ◊ I-TLA isebezisa indlela yobukoloniyalı neyomthetho wocalucalulo kuba ibeka iinkokheli zomthonyama ngentla koluntu.
- ◊ Izinto ezimbalwa zedemokhrasi ebezikwi-Framework Act ziyanuswa.
  - » Konke ukuthathwa kwezigqibo kwensiwa ngamabhunga emveli, izindlu zasebukhosini norhulumente ngaphandle kwemfuneko yokufuna imvume yabantu abachaphazelekileyo kuloo ndawo.
  - » Ithathele indawo iKhowudi Yokuziphatha yamabhunga emveli ephantse ifane nomgaqo Wokuziphatha woMthetho weeNkqubo zikaMasipala osebenza kumagosa anyuliweyo, ngokususa zonke izikhombisi "zomphakathi" kunye "nedemokhrasi".
  - » Ithatha indawo yoxanduva lweenkokheli emveli kunye nabacebisi ukuze benze "*ngokomdla woluntu lwemveli*" ngokoxanduva "*lokwenza ngokomdla..... webhunga*".



- » Umgaqo Wokuziphatha omtsha wongezelela amasolotya obumfihlo anokusetyenziswa ngamabhunga emveli ukuze izinto ekuxoxwa ngazo kunye nezigqibo azithathayo mayela nezinto zoluntu zibe yimfihlo.
- » I-TKLA ayisafuni amabhunga emvelo ukuba athethe ngeengxelo zayo, iimeko zezimali nezipho neminikelo kuluntu lwayo, kodwa ngoku kufuneka kuthunyelwe ingxelo kwiNkulumbuso.
- » Ibangela okanye inciphise uthatho-nxaxheba lomphakathi wemveli kwimveli karhulumente.
- » Inciphisa iindlela zokwenza izinto ngokubhencekileyo noxanduva lobunkokheli bemveli; kwaye
- » Ifuna kusetyenziswe iibhanki ezilawulwa ngurhulumente kuluntu lwemveli - inkqubo ebonakaliswe ivulela urhwaphilizo nobuqhetseba.

## **5. Iyakuphepha ukusilela kukarhulumente ukutshintsha amaziko emveli**

Xa Umgaqo-siseko uba ngumthetho eMzantsi Afrika, urhulumente waqaphela imfuneko yongxamiseko lwamaziko obunkokheli bemvelo noxabiso lwentando yeninzi - inkubo ebizwa 'ngotshintsho' Oku kungenxa yokuba uninzi lwesintu lulahlekelwe yintembelo kwinkokheli zemveli emva kokuba ucalucalulo noorhulumente bekoloniyal bezisebenzise njengezixhobo zengcinezelo kwixesha eligqithileyo.

- ◊ I-Framework Act ibonelele ngotshintsho lamagunya esizwe kumabhunga emveli ngokhetho - icela i-40% yamalungu azokhethwa luluntu nokuba i-1/3 ibe ngamabhinqa.
- ◊ IKomishoni yeeMbambano yoKhokelo IweMveli namaBango ebekelwe ukuphanda usasazeko lweembambano namabango malunga nokuba ngubani ekufanele abe sesikhundleni sokhokelo lwemveli.
- ◊ Zombini iindlela zisilele - kwamanye amaphondo unyulo beluqhutywa ngendlela engafanelekanga emva kokunqunyulwa komhla, ngoxa eLimpopo kungazange kuqhutywe lunyulo.
- ◊ Uninzi lofumaniseko IweKomishoni lubekelwe ucelo-mngeni enkundleni.
- ◊ I-TKLA ayakhi macebo zindlela ezisebenzayo ukuze ijamelane noxanduva lwamagunya esizwe angatshintshanga. Kunoko ibeka inkubo yotshintsho olusileleyo ukuba iqhubeka isezenza.
- ◊ IKomishoni ivaliwe ngaphantsi kwe-TKLA, ngoxa iimbambano zisaqhubeka.



## **6. Kudala isigaba sesine sikarhulumente**

Umgaqo-siseko ubonelela kuphela ukuba ibe ngamagunya onlyuliweto ukuba abe negunya lokuphatha. Oko kubalulekile ukuqinisekisa ukuba abemi boMzantsi Afrika banakho ukubabamba abo basemagunyeni ukuba baphendule ngonyulo.

- ◊ Sekunjalo, iCandelo 25 le-TKLA (jonga iphepha 33) liyawavumela amasebe karhulumento ukuba abele imisebenzi aqhele ukuyenza kwiinkokheli zemveli kunye namabhunga ngohlobo 'lweendima' ezingacacanga.
- ◊ Isibonelelo esifanayo kuMthetho weNkqubo-sikhokelo sikhokelele ekubeni oogunyaziwe bemveli bathathe uluhlu olubanzi lwamagunya afanele ukuba ngoomasipala okanye amanye amaqela oluntu.
  - » Ukukhutshwa kweleta zobungqina, ezifunekayo ukuze abantu bafikelele kwiinkonzo ezibalulekileyo ezzinje ngeZazisi kunye nokuvula iiakhawunti zebhanki.
  - » UCwangciso lweNdawo kunye noMthetho woLawulo lokuSetyenziswa koMhlaba we-16 wezigqibo zokusetyenziswa komhlaba ngo-2013.
  - » Ulwabiwo lomhlaba.
- ◊ linkokheli zemveli azonyulwa kwaye ke ngoko akufuneki babambe amagunya orhulumente. Ukuba bawasebenzisa kakubi la magunya, abanakuphenduliswa!

## **7. Baphatha abahlali bamaKhoi-San ngokwahlukileyo**

  - » iindawo zokumamela kude noluntu Iwasemaphandleni;
  - » kwiindawo ekuqhutywa kuzo iintlanganniso ikopi yoMthetho oqulunwayo ibingekho; kwaye
  - » uMthetho oqulunwayo ubufumaneka ngesiNgesi kuphela.
- ◊ Kwiindawo ezininzi lo Mthetho uYilwayo wawubhengezwa njengochaphazela uluntu IwamaKhoi-San kuphela.
- ◊ Ilizwi leenkohkheli zemveli lalilawula ezinye iintlanganiso.

Ezi zithethe yintando yesininzi, ukuphendula  
kunye nenkululeko. I-TKLA ikwasongela  
amalungelo oluntu kwipropathi, ukulingana,  
inkululeko yokuzibandakanya, ubulungisa  
bezolawulo kunye nelungelo lokuthatha  
inxaxheba koluntu nakwezopolitiko.

**I-ARD kanye nabemi basemaphandleni  
bachasene neenxalenye ze-TKLA ezisongela  
ubomi babo kanye namalungelo omhlaba.  
Baxhalabile yi-TKLA kuba babonile ubunzima  
kanye neengxaki eziziswe yi-Framework Act.**

- ◊ Ukususela oko umthetho-sikhokelo ubusebenza:
  - » eLimpopo, abasemagunyeni bakwazile ukufumana izithintelo zenkundla ukunqanda amalungu oluntu ekubambeni iintlanganiso. Oku kusemva kokuba iNkundla yoMgaqo-siseko ivakalise oku kungekho semthethweni kwi-*Pilane vs Pilane* (2013).
  - » Amagunya emveli eLimpopo kanye neendawo zaKwaZulu-Natala bebehlawulisa iirhafu zabemi basemaphandleni. Xa abemi basemaphandleni besilela ukuhlawula ezi rhafu, bebengabunikwa ubungqina bokuhlala, ekufuneka bevule iiakhawunti zebhanki kwaye bafumane iZazisi. Abantu abanikwanga iindawo zokungcwaba kanye nezinye iinkonzo ngokusilela ukuhlawula irhafu.
  - » Uluntu IwaseLimpopo luye Iwangcungcutheksa yinkokheli yemveli ephezulu ethi inyanelise igunya layo kubo. Xa abahlali bengayithobeli imiyalelo yenkokheli yemveli, usebenzisa umkhosi wakhe wabucala obizwa ngokuba "yi-Green Berets". Uchithe izakhiwo ezakhiwe ngabantu kuba bengenayo imvume yakhe. liGreen Berets zikwasetyenziselwa ukuhlasela, ukuxhwila, nokugcina kwizakhiwo zebhunga lemveli, nawaphina amalungu oluntu aphikisana nezinyanzelo zale nkokheli yemveli.



- ◊ Ityala lenkundla liza kuchaza iingxaki ezithe zenzeka ngexa iPalamente kunye nezindlu zowiso-mthetho zamaphondo zisebenza ne-TKLA kwaye ibonise ukuba kutheni le nkqubo ingahambelani nomgaqo-siseko-ngakumbi imiba yokufumana ingxelo ebantwini.
- ◊ Ityala lizakucacisa ezinye zeengxaki ngamagama kunye namacandelo eTKLA.
- ◊ I-ARD ixhasa ukwamkelwa kwamaKhoi namaSan kwaye ibambisene nabantu abangamaKhoi namaSan abaza kuchaphazeleka kakubi ngulo Mthetho. Umhlaba wabo kunye namalungelo edemokhrasi nawo asemngciphekweni.
- ◊ I-ARD ikwaxhasa umthetho wesintu ophilayo kunye nobunkokheli bemveli obunika ingxelo obufumana ukuba semthethweni ebantwini. I-ARD iyakuxhasa umthetho-sikhokelo okhuthaza olo hlobo lobunkokheli bemveli kunye nomthetho wesintu.
- ◊ Kuyenzeka ukuba urhulumente abamkele abantu abangamaKhoi namaSan, ubunkokheli bemveli kunye nomthetho wesintu ophilayo ngaphandle kokugrogrisa amalungelo abemi basemaphandleni.

23. (1) Urhulumente wesizwe kunye norhulumente wephondo kufuneka bamisele umthetho okanye amanye amanyathelo njengoko kunokufuneka—

(a) ukuseka nokuqinisa ubukhulu bobukhosi okanye ibhunga lobundlunkulu, ibhunga lemveli eliyintloko, ibhunga lemveli, ibhunga lamaKhoi-San unye nebhunga lesintu ukugcwalisa imisebenzi yayo,eyo nxaso ihlanganisa ukusekwa ngokwezimali kunye nokuhlinzekwa ngoawulo; kunye

(b) zibeke iliso kwaye zilawule iimali zala mabhunga: Ngokuxhomekeke ekubeni iSebe kufuneka, ngokwecandelo 62, libeke iliso kulawulo lwemali yelo bhunga.

(2) Inkulumbuso yephondo ingathi, emva kokucebisana nebhunga lobukhosi okanye lobundlunkulu, ibhunga lemveli eliyintloko, ibhunga lemveli okanye ibhunga lamaKhoi-San elikwiphondo elithile-

(a) ukumisela inani nenani lemivuzo yezithuba ezifunekayo ukwenza imisebenzi yolawulo, yezemali kunye nemisebenzi enxulumene noko enxulumene nemisebenzi yebhunga elithile;

(b) amisele nayiphi na eminye imiqathango yenkonzo eseberiza kwezo zithuba; kwaye

(c) ukutyumba abantu abafanelekileyo kwizikhundla ezinjalo ngokungqinelana neenkubo zokugaya abasebenzi ezisebenza kuloo rhulumente wephondo okanye kumagosa wesibini kurhulumente wephondo ukuba enze imisebenzi enjalo.

(3) (a) Ngenjongo yecandelwana (1) iNkulumbuso kufuneka, ngokucebisana uNondyebo wePhondo ochaphazelekayo nangokuxhomekeke kuwo nawuphi na umthetho okanye amanye amanyathelo njengoko kucamngcwé kwicandelwana (1), kubangela ukuba kuvulwe iakhawunti yebhunga ngalinye elisekwe ekubhekiswe kulo kwicandelwana (1) ekufuneka lihlawulwe kulo—

- (i) yonke iminikelo yokuzithandela eyenziwe ngamatlungu oluntu oluchaphazelekayo;
- (ii) zonke iimali ezivela kuyo nayiphi na ipropati eyeyayo okanye elawulwa lelo bhunga;
- (iii) nawuphina umnikelo wemali owenziwe kwelo bhunga nangubani na, liqumrhu okanye iziko; iimali njengoko kunokugqitywa okanye kuvunyelwene yiNkulumbuso;
- (iv) nayiphi na imali ebhatalwa libhunga ngokuhambelana nezibonelelo zokusebenza kunye okanye isivumelwano njengoko icandelo 24 libonelela kunye
- (v) naziphi eziye izimali ezinokugqitywa okanye zivunywe yiNkulubaphathiswa.

(b) Ngeenjongo zolawulo lwayo nayiphina iakhawunti ekubhekiswe kuyo kumhlathi (a), iNkulumbuso kufuneka, ngokubonisana noNondyebo wePhondo ochaphazelekayo nangokuxhomekeke kumhlathi (c) nayo nayiphi na imithetho okanye amanye amanyathelo njengoko kuxelwe kwisiqendwana (1)—

- (i) iinkqubo zezemali nolawulo olusebenzayo kuloo akhawunti;
- (ii) nayiphi na imiqathango esebenzayo kuloo akhawunti;
- (iii) utyalomali Iwayo nayiphi na imali libhunga elichaphazelekayo; (iv) ukuhlawulwa kwayo nayiphi na inkcitho libhunga elichaphazelekayo;
- (v) iinjongo ezinokuthi zisetyenziselwe nayiphi na imali kwiakhawunti ibhunga elifanelekileyo;
- (vi) ukuvalwa kwazo naziphi na ezinye ii - akhawunti, kubandakanya neakhawunti yetrasti kodwa kungabandakanya iakhawunti yetrasti njengoko kuchaziwe kwicandelo 10 loMthetho woLawulo IwePropati yeTrasti, ka - 1988 (uMthetho onguNombolo. 57 ka - 1988) enye iakhawunti okanye iakhawunti yethemba kwiakhawunti echazwe kumhlathi (a);
- (vii) iimfuno zokunika ingxelo ezisebenza kuloo akhawunti; kwaye
- (viii) nawaphi na amanye amanyathelo anokubonwa eyimfuneko kwiNkulumbuso ukuqinisekisa ulawulo olululo nolululo lweakhawunti enjalo, kwaye anganyula naliphi na igosa kurhulumente wephondo ukuba lincedise ibhunga elichaphazelekayo kulawulo lwaloo akhawunti okanye ukulawula loo akhawunti egameni lebhunga elifanelekileyo: Ngokuxhomekeke ekubeni ukulungiselela imihlathana (ii) ukuya ku (vii) iNkulumbuso

kufuneka ibonisane nebhunga elifanelekileyo phambi kokwenza nasiphi na isigqibo njengoko kuchaziwe kule mihlathana.
